Re : Progress report on the provision of financial assistance to unrelated party by Karmarts Public Company Limited

Dear Sir :

Karmarts Public Company Limited ("Company") would like to inform the progress on the provision of financial assistance to unrelated party by Karmarts Public Company Limited with reference to IR 022/16 dated on May 23, 2016 and reference to IR 041/16 dated on December 14, 2016. The transaction is summarized as follows:

**1. Triple P Asset Company Limited**

Karmarts Public Company Limited issued a short term one-year loan amounting to Baht 50.00 million (Fifty million Baht) to Triple P Asset Company Limited at interest rate of 15% per annum. Prior to expiry on May 18, 2017, monthly installments comprising principal sum and interest shall be payable on the 18th day of every month at not less than Baht 2,000,000.00 (Two million Baht) and issue a short term one-year loan amounting to Baht 5.00 million (Five million Baht) to Triple P Asset Company Limited at interest rate of 15% per annum. Prior to expiry on December 13, 2017, monthly installments comprising principal sum and interest shall be payable on the 13th day of every month at not less than Baht 250,000.00 (Two hundred and fifty thousand Baht) till full repayment is made.
